### SEWER PROJECTS

Ansted, Town of-Line repl (Engineering fee waiver) Kathy Emery described the request and it is technically feasible.

The Technical Review and Funding committee recommends the Town of Ansted engineering fee waiver request be approved.

# Kanawha PSD-Winifrede flood rehb (New application)

Kathy Emery described the request and it is technically feasible.

The Technical Review and Funding Committee recommends the Kanawha PSD pursue a \$1,552,500 FEMA grant, a \$487,500 IJDC grant and a \$60,250 IJDC PFA funds for an estimated project cost of \$2,100,250.

Fort Gay, Town of-Sys imprvs (Cost & funding chg)

The Technical Review and Funding Committee recommends the Town of Fort Gay pursue a \$2,300,000 US ACE grant, a \$1,500,000 CWSRF DF grant, a \$1,700,000 WDA EEGF, a \$1,000,000 IJDC grant and \$100,000 IJDC PFA grant for an estimated cost of \$6,600,000.

### Clay, Town of-Tank Imprvs (Cost and funding chg) Meredith Vance described the request.

The Technical Review and Funding Committee recommends the Town of Clay be approved to pursue a \$780,000 ARC Grant, and a \$477,500 IJDC grant for an estimated total project cost of \$1,257,500.
